

Case Study: Top Pharma

A global Pharmaceutical company with more than 50,000 employees across the world has been using Orbit for five years for RMP and REMS tracking.

The Problem

Hundreds of Risk Management Plans, no way to track them

Our client found that controlled strategic planning and operational tracking of patient risk management was not being conducted in a proactive, cohesive, and transparent manner across all global functions and markets. It was difficult to scale because their existing techniques for tracking their Risk Management Plans were local and often ad hoc. While the process in place functioned, it was manual and came with considerable overhead. Since it was not centralized, it was time-consuming and resource intensive for Global Safety Officers to get the complete picture of their processes.

Their heavy reliance on disconnected and passive applications to store compliance data and track it, including spreadsheets, emailed documents, and scanned and rescanned paper forms, meant that there was a risk that they couldn't demonstrate robust risk management to regulatory authorities.

Additional Challenges

Missed Deadlines

Manual tracking processes made it difficult to obtain information necessary to meet deadlines.

Unharmonized Data

Numerous versions of tracking documents created a major disconnect with data accuracy.

Lack of Global Oversight

Proper oversight was often sacrificed to save the resources needed to create reporting.

No Audit Trail

"Data tracking" meant following the email chain of spreadsheets; ineffective and time-consuming.

No Single Source of Truth

With no centralized repository, finding current information on-demand was nearly impossible.

Wasted Resources

Safety resources were spending enormous amounts of valuable time amassing information.

Critical Inspection Findings

Absent a system for globally tracking RMPs, the chance of inspection findings are higher.

Market Access Restrictions

Inadequate auditing of RMP activities and their statuses carry increased risk to the bottom line.

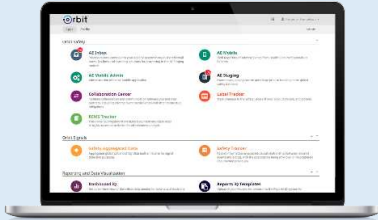
